

The five (5) trustee zones for Kamiah Joint School District No. 304 are as follows:

Trustee Zone No. 1

Beginning at a point where the Lolo Creek intersects with the Clearwater River in Section 14, TWP 35N, R 2 EBM; thence in a southeasterly direction up the center of the Clearwater River to where the Clearwater River intersects with U.S. Hwy 12; thence in a northwesterly direction following the center of the Woodland Rd approximately 1/4 mile to the point where the Woodland Rd intersects with Glenwood Rd (Tom Taha); thence up the center of the Glenwood Rd (Tom Taha) in a northeasterly direction to the point where the Glenwood Rd intersects with the Kidder Ridge Rd Section 2, TWP 33N, R4 EBM; thence in a southeasterly direction down the center of Kidder Ridge Rd approximately 1 1/2 mile to the northwest corner of the southeast quarter of the southeast quarter of Section 11, TWP 33N, R4 EBM; thence east 1/4 mile to northeast corner of the southeast quarter of the southeast quarter of Section 12, TWP 33N, R4, EBM; thence south 1/4 mile to the southwest corner of section 12, TWP 33N, R4, EBM; thence east 1 mile; thence south 1 mile to the southwest corner of section 18, TWP 33N, R5, EBM; thence east 6 miles to the southeast corner of Section 13, TWP 33N, R5, EBM; thence north approximately 6 miles to the intersection with the Lolo Creek in Section 13, TWP 34N, R5, EBM following the common line of Section 13, TWP 33N, R5, EBM and Section 18, TWP 33N, R6, EBM; thence in a westerly direction down the center of the Lolo Creek to the point of beginning, where the Lolo Creek intersects with the Clearwater River in Section 14, TWP 35N, R2, EBM.

Trustee Zone No. 2

Beginning at a point where the Clearwater River intersects with U.S. Hwy 12; thence in a northwesterly direction following the center of the Woodland Rd approximately 1/4 mile to the point where the Woodland Rd intersects with the Glenwood Rd (Tom Taha); thence up the center of the Glenwood Rd (Tom Taha) in a northeasterly direction to the point where the Glenwood Rd intersects with the Kidder Ridge Rd Section 2, TWP 33N, R4, EBM; thence in a southeasterly direction along the center of Kidder Ridge Rd approximately 1 1/2 mile to the northwest corner of the southeast quarter of the southeast quarter of Section 11, TWP 33N, R4 EBM; thence west 1/4 mile to the northwest corner of the southwest quarter of the southeast quarter of Section 11, TWP 33N, R4, EBM; thence south 1/4 mile; thence west 1 mile; thence south 1 mile; thence west 1/2 mile to the southwest corner of Section 15, TWP 33N, R4, EBM; thence north 1/2 mile; thence west 2 miles; thence south 1 mile to the southeast corner of the northeast quarter of Section 19, TWP 33N, R4, EBM; thence west 1/2 mile to the center of the Clearwater River and the middle point of Section 19, TWP 33N, R4, EBM; thence up the center of the Clearwater River in a northwesterly direction to the point of beginning where the Clearwater River intersects with U.S. Hwy 12.

Trustee Zone No. 3

Beginning at a point where the Clearwater River intersects with the channel of the Six Mile Creek Section 7, TWP 34N, R3, EBM; thence in a westerly direction up the center of the Six Mile Creek to the intersection of the Six Mile Creek with the common line of Sections 11 & 12, TWP 34N, R2, EBM; thence south to the southwest corner of Section 12, TWP 34N, R2, EBM; thence east 1/2 mile; thence south 1/2 mile; thence east 1/2 mile; thence south 2 1/2 miles to the southwest corner of Section 30, TWP 34N, R3, EBM; thence east 2 miles to the southwest corner of Section 28, TWP 34N, R3, EBM; thence south 1/2 mile on the common line of Sections 32 & 33, TWP 34N, R3, EBM; to it's intersection with State Hwy 64; thence in a southeasterly direction down the center of State Hwy 64 to it's intersection with Pine St in Section 1, TWP 33N, R3, EBM; thence south down the center of Pine St to where Pine St intersects with 9th St; thence east down the center of 9th St to where 9th St intersects with Idaho St; thence north down the middle Idaho St to where Idaho St intersects with U.S. Hwy 12; thence east down the center of U.S. Hwy 12 to where U.S. Hwy 12 intersects with the Clearwater River; thence in a northwesterly direction down the center of the Clearwater River to the point of beginning, where the Clearwater River intersects with the Six Mile Channel.

Trustee Zone No. 4

Beginning at a point where the Clearwater River intersects with Lawyers Creek; thence in a southwesterly direction up the center of Lawyers Creek to where Lawyers Creek intersects with Roby Rd; thence north on Roby Rd to where Roby Rd intersects with State Hwy 162; thence in a northeasterly direction approximately 3/4 mile down the center of State Hwy 162 to the southwest corner of the southeast quarter of the northeast quarter of Section 11, TWP 33N, R3, EBM; thence north approximately 1 mile to where Hwy 64 intersects with the northwest corner of the northeast quarter of the southeast quarter of Section 2, TWP 33N, R3, EBM; thence in a westerly direction down the center of State Hwy 64 to the common line of Sections 32 & 33, TWP 34N, R3, EBM; thence south approximately 1 1/2 miles to the southwest corner of Section 4, TWP 33N, R3, EBM; thence west 2 1/2 miles to the northwest corner of the northeast quarter of Section 12, TWP 33N, R2, EBM; thence south approximately 1 mile to the intersection with Lawyers Creek; thence southwesterly down the center of Lawyers Creek to the intersection of Lawyers Creek with the center east - west line of Section 27, TWP 33N, R2, EBM; thence east 1 3/4 miles to the center point of Section 25, TWP 33N, R2, EBM; thence north 3/4 mile to the northwest corner of the southwest quarter of the southeast quarter of Section 24, TWP 33N, R2, EBM; thence east 1/2 mile; thence south 1/4 mile to the southeast corner of Section 24, TWP 33 N, R2, EBM; thence west 1/4 mile; thence south 1/2 mile; thence east 1/2 mile to the northeast corner of the northwest quarter of the southwest quarter of Section 30, TWP 33N, R3, EBM; thence south 1 mile to the southeast corner of the southwest quarter of the of the northwest quarter of Section 31, TWP 33N, R3, EBM; thence west 1/4 mile; thence south 1/2 mile to the southwest corner of Section 31, TWP 33N, R3, EBM; thence east 1 1/4 mile; thence south 1 1/4 mile to the southeast corner of the northwest quarter of the northwest quarter of Section 8, TWP 32N, R3, EBM; thence west 1/4 mile; thence south 3/4 mile to the southwest corner of section 8, TWP 32N, R3, EBM; thence east 3/4 mile to the

northwest corner of the northeast quarter of the northeast quarter of Section 17, TWP 32N, R3, EBM; thence south 1 mile; thence west 1/4 mile to the northwest corner of the northwest quarter of the northeast quarter of Section 20, TWP 32N, R3, EBM; thence south 1/4 mile to the southwest corner of the northwest quarter of the northeast quarter of Section 20, TWP 32N, R3, EBM; thence east 1/4 mile; thence south 1/4 mile to the southwest corner of the southeast quarter of the northwest quarter of Section 20, TWP 32N, R3, EBM; thence east 1 mile to the southeast corner of the southwest quarter of the northwest quarter of Section 21, TWP 32N, R3, EBM; thence north 1/2 mile; thence west 1/4 mile to the northwest corner of Section 21, TWP 32N, R3, EBM; thence north 1 mile; thence east 1 mile to the southeast corner of Section 9, TWP 32N, R3, EBM; thence north 1/2 mile; thence east 1 mile; thence south 2 1/4 miles to the northwest corner of the southwest quarter of the southwest quarter of Section 23, TWP 32N, R3, EBM; thence east 2 miles to the northeast corner of the southeast quarter of the southeast quarter of Section 24, TWP 32N, R3, EBM; thence north 6 1/4 miles to the southwest corner of the northwest quarter of Section 19, TWP 33N, R4, EBM; thence east 1/2 mile to the center of the Clearwater River; thence up the center of the Clearwater River to the point of beginning where the Clearwater River and Lawyers Creek intersect.

Trustee Zone No. 5

Beginning at a point where the Clearwater River intersects with U.S. Hwy 12; thence west down the center of U.S. Hwy 12 where U.S. Hwy 12 intersects with Idaho St; thence south down the center of Idaho St to where Idaho St intersects with 9th St; thence west down the center of 9th St to where 9th St intersects with Pine St thence north down the center of Pine St to where Pine St intersects with State Hwy 64; thence in a northwesterly direction down the center of State Hwy 64 approximately 1/2 mile to the northeast corner of the northeast quarter of the southeast quarter of Section 2, TWP 33N, R3, EBM; thence south approximately 1 mile to the northwest corner of the southeast quarter of the northeast quarter of Section 11, TWP 33N, R3, EBM and the intersection of State Hwy 162; thence in a southwesterly direction where State Hwy 162 intersects with Roby Rd; thence south on Roby Rd to where Roby Rd intersects with Lawyers Creek; thence up the center of Lawyers Creek in a northeasterly direction to a point where Lawyers Creek intersects with the Clearwater River; thence in a northwesterly direction up the center of the Clearwater River back to the point of beginning where the Clearwater River intersects with U.S. Hwy 12.
